## CALIFORNIA ATTORNEY GENERAL RELEASES UPDATED NOTICE OF MODIFICATIONS TO PROPOSED CCPA REGULATIONS

Yesterday, the California Attorney General released an updated notice of modification to the proposed California Consumer Privacy Act ("CCPA") regulations because the notice and modifications released February 7, 2020 omitted a revision. See our prior ALERT dated February 10, 2020. The omitted revision applies to the record keeping requirements of a business subject to the CCPA. Under the modified regulations, a business that alone or in combination, buys, receives for the business's commercial purposes, sells or shares for commercial purposes, the personal information of 10 million or more consumers in a calendar year must compile certain information relating to consumer requests under the CCPA and disclose this information within the business's privacy policy or on its website. Before the modification, this requirement applied to businesses that bought, received, sold or shared the personal information of 4 million or more consumers.

The deadline for public comments has been extended to February 25, 2020. Please contact us with any questions. □
